GENERAL GUIDELINES:

- 1. Target Group Youth in the age group of **18-30 years** of age from their respective institute.
- 2. The contestants should bring with their Valid Photo Identity card.
- 3. Last date for registration: January 10, 2024
- 4. Detailed schedule of INYS will be conveyed through mail.
- 5. Registration fees for each contestant is INR 250/-. In case of Group registration, each member has to get himself/herself registered individually.
- 6. Registration fees include: Registration kit, participation certificate, food coupons and eligibility to win cash prizes.
- 7. Each participant has to carry the payment receipt/copy of screenshot along with them at the venue.
- 8. The contestants will be judged by a panel of judges. The decision of the judges with regard to the result of the competition shall be binding.
- 9. A **Certificate of Participation** will be provided to all registered contestants.
- 10. All contestants are expected to maintain decorum at the venue where the Contest will be held.
- 11. The Institute reserves the right to take appropriate action for any unethical, unprofessional and immoral conduct of any of the contestants.
- 12. The Judging Criteria are set and decided by the Event Organising Committee.
- 13. Attractive Prizes and Trophies of Rs. 2,00,000. Each Competition would be evaluated separately for cash prizes. Top 3 winners from each contest will be awarded with cash prizes.

- III. Presentation/Speaking style (Mannerisms, Audience contact and voice modulation, ability to keep the audience engaged by their speaking style).

c) Dress Code & Mannerism

- i. The dress code will be formal.
- ii. The participants should wear simple but smartly washed and pressed clothes.
- iii. The participants should also wear polished/clean footwear.
- iv. They should be neat and clean and maintain the personnel hygiene with proper haircut.
- v. They should exhibit good manner and etiquettes.

14. CULTURAL CONTEST.

MUSIC (SINGING/ PLAYING MUSIC/ INSTRUMENT)

- 1. Each performer will be given a maximum time slot of 3-4 minutes for their performance.
- 2. Performance must be a Folk/Indian Classical/Semi-classical/Western song.
- 3. Instruments and music piece to be carried by participants for their respective performance.
- 4. Film/Cinema/Recorded Songs are not allowed in classical performance. Item can be presented in either Hindustani or Carnatic style. Sufficient thought & care must be exercised in the choice of raga and composition.
- 5. Music Pendrive (If any) must be handed over to the Organizing Committee on the day of arrival / 1 hour before the start of competition.

DANCE (SOLO/ GROUP)

- 1. A maximum length of solo item is at least 3 minutes and can extended to a maximum length of 4 minutes, where as a minimum length of Group item is at least 4 minutes and can extended to a maximum length of 5 minutes.
- 2. Dance form should be essentially Classical/Western/ Folk Dance.
- 3.Use of props is allowed (participants should manage it at their own).
- 4. Sound track to be brought in pendrive and must be handed over to the Organizing Committee on the day of arrival / 1 hour before the start of competition.
- 5. The participating team will be responsible for removal of their sets, properties etc immediately after the completion of their performance.
- 6. Performance should not include foul language, should not hamper any religious sentiments and should not create any political unrest. Any performance containing above elements will be disqualified on the spot.













THEATRE (DRAMA/STANDUP COMEDY, ANY OTHER)

- 1. Each performer will be given a maximum time slot of 3-4 minutes for their performance.
- 2. Participant may mimic sound of machines and speeches of well-known persons etc including film personalities.
- 3. Contestants must not use any foul/unparliamentarily language. If the judging panel concludes that the performance violated this guideline, the contestant/contestants will be asked to stop the performance or the performance disqualified from the competition.
- 3. Use of make-up, drapery, background music is allowed. No personal remarks, aspersions, character assassination etc. is allowed
