## IT dept launches taxevasion probe against social media influencers

The department initiated the action last week after it searched about 10 YouTubers and other social media influencers mostly young artistes and actors in Kerala. The sources said a "data analytics" investigation undertaken by department found out that these social media influencers and online content creators are making "substantial" earnings but either not showing or under-reporting it in their income tax returns or filings, largely due to ignorance of tax laws. The Central Board of Direct Taxes, the administrative authority of the I-T department, brought new TDS provisions last year regarding benefits received in a business or profession and said such perquisites can either be in cash or in kind or partly in both of these forms. The Budget 2022-23 brought in a new section -194R in the I-T Act, which requires deduction of tax at source at the rate of 10 per cent by any person, providing any benefit or perquisite exceeding Rs 20,000 in a year to a resident, arising from the business or profession of such resident.

## Ideaforge IPO becomes first to cross 100 times subscription since 2022

Ideaforge Technology has become the first IPO since 2022 to receive subscriptions over 100 times, marking a significant achievement for the company. The drone maker's public issue was subscribed more than 106 times, generating over Rs 33,000 crore worth of bids. Qualified institutional investors led the way, with their reserved portion being oversubscribed 125.81 times. Retail investors and high net worth individuals also showed strong interest, subscribing over 85 times and 80 times, respectively. The total fundraising planned by the unmanned aircraft systems maker via IPO was Rs 567 crore of which Rs 254.88 crore was already raised via anchor book on June 23, a day before opening the issue. The remaining Rs 312 crore issue opened for subscription during the current week ending June 30. Market believe that Ideaforge Technology's success can be attributed to its first-mover advantage in the drone-making industry and anticipate that it will trade at expensive valuations.

Chopra currently leads the Diamond League standings in the men's javelin throw event.

## CCI approves acquisition of TCNS Clothing by Aditya Birla Fashion

The Competition Commission of India (CCI) has approved the acquisition of TCNS Clothing Co Limited by Aditya Birla Fashion and Retail Limited. Aditya Birla Fashion and Retail will acquire 51% of the expanded share capital of TCNS Clothing, which is the manufacturing, engaged in distribution, and sale of women's apparel, jewellery, footwear, and beauty products. Aditya Birla Fashion and Retail is part of the Aditya Birla conglomerate and operates retail stores, online platforms, and ecommerce marketplaces for branded products in the apparel, footwear, and accessories segment.

# Merger of HDFC twins to be effective from today

The Boards of mortgage major Housing Development Finance Corporation (HDFC Ltd) and the country's largest private sector lender HDFC Bank Friday approved July 1 as the effective date of their merger. The combined entity with a capitalisation of Rs 14.37 lakh crore is likely to benefit both the shareholders and customers. As per the merger scheme, HDFC Bank will issue and allot to eligible shareholders 42 new equity shares of the face value of Re. 1 each, credited as fully paid-up, for every 25 equity shares of the face value of Rs 2 each fully paid-up held by such shareholder in HDFC Ltd as on the Record Date of July 13, 2023. After the amalgamation, HDFC Bank will be completely owned by public shareholders and existing shareholders of HDFC Ltd will own a 41 per cent stake in the bank. The foreign stake is around 8 per cent in the bank and is likely to increase. With this merger, HDFC Bank gets an unparalleled advantage through the mortgage portfolio providing it a quantum leap in distribution to semi urban and rural areas with a huge opportunity to cross sell bank products to a very sticky client base.
