Trump moves to end birthright citizenship: What it means for Indians

US President Donald Trump signed an executive order initiating the process to end birthright citizenship on January 20, marking his return to the White House. The order, part of a series of executive actions, seeks to deny automatic citizenship to children born in the US whose parents lack legal immigration status.

The new policy denies US citizenship to children if their father is not a citizen or permanent resident and their mother is in the country illegally or on a temporary visa. Set to take effect in 30 days, it challenges long-standing US policy, prompting immigration advocates to file a lawsuit.

During his campaign, Trump claimed birthright citizenship was being exploited, especially by immigrants from India and China. His executive order revokes automatic citizenship for children of parents on temporary work visas, like H-1B, or those awaiting green cards.

As of 2024, the US had a population of over 5.4 million Indian Americans, accounting for 1.47% of the nation's population. Approximately two-thirds are immigrants, while 34% are US-born, according to official data.

Meanwhile, Indian immigrants, who are already facing long green card backlogs, would likely have to witness further delays if their children are no longer entitled to citizenship at birth.

PM Modi's message at AI Action Summit: Open source, sustainability, job optimism

While he called for global collaboration to harness Artificial Intelligence (Al) for economic growth, social transformation and sustainable development, Prime Minister Narendra Modi emphasised the need to build quality data sets that are "free from biases" and embrace opensource models. He also carried a rather hopeful message on the potential impact of Al on jobs.

Open source, no biases

Modi's call to embrace the open source architecture comes at a time when China's low-cost open source DeepSeek model has shaken up the Al industry, drawing comparisons with its heavy-pocketed Western counterparts like OpenAl and Google. Unlike DeepSeek, both the American models are not open sourced, although there has been some industry criticism of the distillation process leveraged by DeepSeek to fine-tune its model.

The emphasis on Al models that are "free from biases" comes in the backdrop of the Indian government looking to fund foundational models that understand the Indian context. In the past, there have been instances where some models have answered similar questions about various world leaders differently.

76th Republic Day: Military strength and cultural heritage shine, tableaux on display

India celebrated its 76th Republic Day with a grand parade showcasing military strength and cultural heritage in New Delhi. Highlights included a focus on women's empowerment, an Indonesian contingent, and debut displays of the Pralay missile and SANJAY battlefield surveillance system.

The country observed its 76th Republic Day on Sunday with a parade in New Delhi showcasing the country's military strength and cultural heritage. The event on Kartavya Path commemorated the adoption of Constitution on January 26, 1950.

The parade included soldiers from military and paramilitary forces, along with their bands, marching in front of leaders and guests. Various tableaux highlighted the country's cultural diversity, including one on the Maha Kumbh.

Indonesian President Prabowo Subianto was the chief guest at the event. A contingent of 342 members from the Indonesian National Armed Forces also participated in the parade, marking the first time troops from Indonesia joined a foreign parade. President Droupadi Murmu and Prime Minister Narendra Narendra Modi were present alongside the visiting dignitary.

Prime Minister Modi began the day by laying a wreath at the National War Memorial to honour the country's fallen soldiers. President Murmu and Indonesian President Subianto arrived at the venue in a traditional buggy, after which the national flag was unfurled

India sees 17.9% increase in FDI inflows, at \$55.6 bn in Apr-Nov in FY25

India's foreign direct investment (FDI) inflows rebounded in FY25, with gross inflows rising 17.9% Y-o-Y to \$55.6 billion during April-November, up from \$47.2 billion in the same period of FY24, according to the Economic Survey.

India's cumulative FDI inflows surpassed \$1 trillion from April 2000 to September 2024, reinforcing its position as a key investment hub. In the first half of FY25, the services sector led with 19.1% of total equity inflows. Other key industries attracting foreign investments included:

- Computer software and
- hardware: 14.1 per cent
- Trading: 9.1 per cent
- Non-conventional energy: 7 per cent
- Cement and gypsum products: 6.1 per cent

These figures reflect India's growing appeal as a hub for technology-driven investments and infrastructure development.

Prayagraj's airport made history by receiving its first international flight in 93 years



Prayagraj received its first international flight in 93 years after a Bhutan Airways plane landed at Prayagraj airport with American billionaire Steve Jobs' wife, Laurene Powell Jobs, on board, The Times of India reported.

After attending the Maha Kumbh Mela, Powell flew back to Bhutan on the same plane. This marked the first international flight from Prayagraj in 93 years.

Allahabad (now Prayagraj) airport was one of the first international airports in India. The first international flight flew to London until 1932, after which international flights were discontinued. The Maha Kumbh Mela brought a unique event to the airport, as it saw an international flight again, this time to facilitate a billionaire. In 1911, Henri Piquet started domestic commercial aviation in India by flying mail from Allahabad to Naini.

India, France step up maritime security cooperation in Indian Ocean Region

India and France are deepening maritime cooperation to achieve a peaceful and secure Indian Ocean Region with New Delhi assuming chair of the Indian Ocean Rim Association (IORA) in 2025 for two years.

India and France, at their recent Maritime Cooperation Dialogue in New Delhi, agreed to develop a joint assessment of maritime security threats in the Indian Ocean Region (IOR). The collaboration aims to counter illicit activities such as piracy, armed robbery, terrorism, smuggling, illegal fishing, cyber threats, and marine pollution. Both nations also committed to ensuring free and secure access to sea lanes through cooperation between their maritime assets and organizations. France, with territories in the IOR, remains a key partner for India in the region.
