Budget 2025 : Big relief for middle-class! No Income Tax payable up to Rs 12 Lakh under new tax regime; PM hails this budget as "people's budget"

In a big boost to the Indian middle class, Finance Minister Nirmala Sitharaman on 1st february announced that there will be no income tax payable for incomes up to Rs 12 lakh, and Rs 12.75 lakh for salaried taxpayers (including standard deduction) in the new tax regime.

Finance Minister Nirmala Sitharaman has put the middle class squarely at the centre of her Budget by announcing nil income tax up to Rs 12 lakh income. Her previous budgets were marked by huge amounts of money marked for capital expenditure aimed at building infrastructure such as railways and highways. In this budget, Sitharaman has decided to raise capital expenditure at a lower rate. The capital expenditure for 2025-26 will be 11.2 lakh crore, marginally higher from Rs 11.1 lakh crore in the previous budget when she had raised it by 11%, slowing down the breathtaking speed in previous years. Known for her prudent budgeting, she has stayed the course on fiscal deficit by announcing it to be 4.4% for next financial year when it was expected to be below 4.5%. Sitharaman has also not taken her attention off the Viksit Bharat roadmap as she has detailed plans to rejuvenate several critical sectors such as agriculture and small industry, calling them engines of development. She has also laid emphasis on human capacity enhancement and skilling as well as outlining a reformist agenda for several sectors. These steps aim at powering economic growth in the long run. Sitharaman's Budget is high on hope when consumer demand is low, inflation has hit the common people, and GDP growth has slumped while concerns over job creation persist.









Average Monthly Consumption Rises In Rural, Urban Areas



Avg MPCE in rural and urban India in 2023-24 estimated at ₹4,122 and ₹6,996, respectively without taking into account the values of items received free of cost by the households through various social welfare programmes

Urban-rural gap in MPCE has declined to 71% in 2022-23 from 84% in 2011-12 and it has further reduced to 70%

Consumption inequality, both in rural and urban areas, has declined in 2023-24 from the previous year for almost all the 18 major states. The Household Consumption Expenditure Survey (HCES) reported a decline in income inequality in 2023-24. The Gini coefficient fell from 0.27 to 0.24 in rural areas and from 0.31 to 0.28 in urban areas, indicating reduced inequality.

In 2023-24, all 18 major states saw an increase in average monthly per capita consumption expenditure (MPCE) in both rural and urban areas. Odisha recorded the highest rural MPCE growth (14%), while Punjab led in urban areas (13%). The lowest increases were in Maharashtra (3% in rural areas) and Karnataka (5% in urban areas). There has been a decline in urban-rural gap in 11 states in 2023-24 compared to the previous year. The lowest urban-rural gap in 2023-24 was seen in Kerala (about 18%) and highest in Jharkhand (around 83%), the survey results showed.

Textile Stocks Jump Up to 9% on Budget Boost for Cotton Farmers



Textile Stocks Surge Up to 9% After Budget Announcements.

Shares of textile companies soared during the special Budget session on Saturday after Finance Minister Nirmala Sitharaman unveiled a five-year mission to boost cotton productivity.

Ambika Cotton Mills surged 9% to Rs 1,630, while KPR Mills climbed nearly 4%. Vardhman Textiles and Arvind also gained, rising 2% and 4%, respectively.

"This initiative, aligned with our integrated 5F vision for the textile sector, will increase farmers' incomes and ensure a steady supply of quality cotton to rejuvenate India's traditional textile industry," Sitharaman said during her record eighth Budget speech.

The mission will focus on improving extralong staple cotton varieties to enhance quality. Sitharaman also announced an increase in the loan limit under the Kisan Credit Card (KCC) scheme from Rs 3 lakh to Rs 5 lakh, benefiting 7.7 crore farmers with short-term credit facilities.

RITU KUMAR INDIAN FASHION DESIGNER

India has an ancient clothing design history and is referred to as a prominent and emerging fashion industry. In ancient times who thought that there would be an industry that would produce an annual revenue of \$165 billion? A handful of skillful designers existed before the 1980s, and one of them was Ritu Kumar. Ritu Kumar is known as one of the best fashion designers in India. She is an Indian Fashion Designer who started her career in a small village in Kolkata with her hand block printing techniques on clothes which amazed people. Ritu Kumar started the Era of Fashion Designing with her amazing designs of Lehengas and Bridal Dresses. Ritu began her journey in the 1960s, while she was studying museology. She visited a small village Serampore in West Bengal. In that village, she found a small colony of hand-block printers who were out of work and needed financial help and employment. That is when the idea came to start a small enterprise of giving designs that the printers began working on.

These hand-block printers created beautiful designer sarees with their outstanding work. She continuously visited exhibitions and fairs to gain popularity and soon she was noticed for her extraordinary designs in India. She experienced the rapid changes in India, which were replacing handmade textiles with machine-made plastics. Ritu Kumar created new globally relevant designs where the handmade textile legacy would remain the original emphasis. Initially, she designed evening clothes and Indian bridal wear, and eventually, after the great success of her designs, Ritu opened stores in different states of India. Now she was at boom and everyone knew Ritu Kumar was a brand. By making an effort, she went international by opening branches in Paris, London, and New York. In 2002 she launched the "Label" brand in partnership with her younger son Amrish Kumar.

She was rewarded the Indira Gandhi Priyadarshini Award, Padma Shree by the Government of India (2013) and many more. Ritu Kumar was the first person to introduce the boutique culture in India. Ritu took the chances and performed outstandingly. She is a true example of a pioneer in the fashion industry thus making a remarkable position in the present era.
